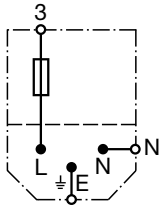


Snap-in mounting type KEA-PRINT

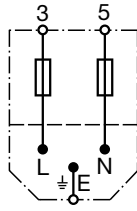

1-pole

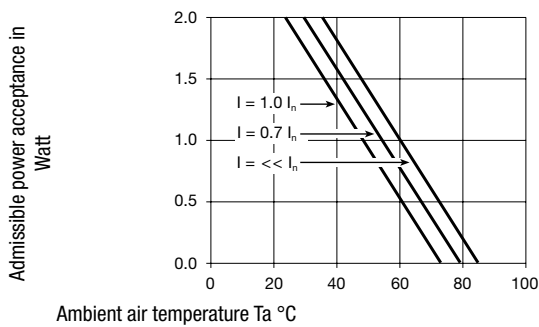


with internal connections
2-pole

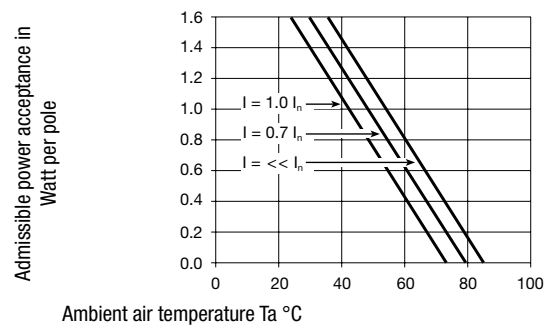


Derating Curves
